In the event that action is required to enforce this agreement, I agree to pay all costs including late fees, shut off fees, collection costs (including an additional 35%), court costs and reasonable attorney's fees. JURISDICTION AND VENUE. The terms and conditions contained within this agreement shall be governed by the laws of the State of Utah and shall be construed and interpreted in accordance with those laws. Any action or proceeding brought by either party which is based upon or derived from, or in any way related to this agreement, shall be brought in a court of competent jurisdiction within the state of Utah. The parties hereto consent to their personal jurisdiction of said court.
